- Sweatshirts are designed to be on a dark material. To change the color of the material would require another set up fee. Decided to wait until another time to do that. Only order 4-5 at a time.
- 3. Session 2 -
  - A. Many skaters bowed out of skating due to Covid -19. There are also two skaters moving into the Bridge group. Numbers might be changing.
  - B. Maybe add an Adult session to the Wednesday programs??

- C. Hesitant to add to Learn to Skate because of Covid potential risk. Adding more would add more people/parents/children entering the building and skating. It is best to keep it in the groups that we have now.
- D. Timing might not work out this season due to construction.
- E. Potential for ice time for an hour of "open" for the SCLP and registered for the program.
- F. By Contract, The SCLP should be receiving 20 hours of ice per week. Check with Jim Brooks on this issue. Right now, not feasible due to Covid, but next year.....
- G. Tupper Lake & Saranac Lake are not running programs at this time.
- H. Jan 3rd, Sunday is the first day of the Second Session for the 2020-2021 season.
